

Congratulations and thank you for putting yourself forward to be on the Rodney Local Board!

I am the Secretary of the Mahurangi Equestrian Advocate Group (MEAG), which was formed following a Matakana Pony Club survey aimed at understanding the local equestrian community - who they are, where they ride, and what they need. From this survey, a group of passionate equestrians came together to establish MEAG.

We are now actively engaging with Auckland Council, Regional Parks, Herenga ā Nuku, Aktive, equestrian networks, the Matakana Community Group (MCG), and other organisations to ensure equestrians are safely included in the wider community, while supporting the needs of a growing and diverse sporting population.

The equestrian community has concerns that its needs are not being heard in our area and the access to facilities and safe places to ride are becoming limited.

Existing equestrian facilities on Council green space land are being reduced or eliminated due to the rapid development of rural towns in favour of other sports.

MEAG's mission is "to safeguard the equestrian community in the Mahurangi area by representing as a central voice that promotes inclusion, safety, and wellbeing for riders of all levels; protects existing facilities and access to local horse-riding tracks and trails; and works to expand these resources for the lasting benefit of future generations".

The National Equestrian Facilities Strategy 2023

According to the latest National Equestrian Facilities Strategy 2023, equestrian sport is growing in general and Rodney has the largest rider group in NZ - see Table 8.3 - however, the least facilities.

Equestrians make a substantial economic contribution at local, regional, and national levels, distinguishing them from many other sports and recreational activities. Key components of the equestrian supply chain are outlined in Figure 1.

Horse Riders are multi-generational; kids, mothers and grandmothers, primarily female¹, achieving the NZ Sports protocol for promoting females in sport, inclusive of all ages and abilities.

Conclusions of the study were that there will likely be heightened importance for equestrian provision in Rodney and Franklin where there is high population growth forecast, and as housing intensification and land repurposing pressures continue as the urban areas expand.
